CLAUSE 1.3 SCOPE, PERSONS BOUND AND LOCALITY

OPDATE 01:10:2019 on and from 1.3.1 This award applies to employees engaged in the Public Service of South Australia.

1.3.2 This award is binding on the Commissioner for Public Sector Employment and on employees of the Commissioner who are employed pursuant to the provisions of the *Public Sector Act 2009* (as amended), whether a member of an Association or not.

1.3.3 This award applies throughout the State of South Australia.

OPDATE 01:10:2019 on and from

'Allowances and penalties' include shift penalties, weekend penalties, fire-fighting allowances, annual allowances in lieu of overtime and uniform allowances.

CLAUSE 1.4 DEFINITIONS

'Employee' means an employee as defined in subclause (b) of section 3 of the Public Sector Act 2009 (as amended).

'Public Service' means the Public Service as defined in section 7 of the Public Sector Act 2009 (as amended).

'Salary' is to include the Whyalla cost of living loading and additional duties allowance payable pursuant to section 46 of the *Public Sector Act 2009* (as amended).

CLAUSE 1.5 RECREATION LEAVE LOADING

OPDATE 01:07:2023 1st pp on or after

- 1.5.1 During a period of recreation leave or pro rata leave an employee is to be paid a loading computed upon the normal salary attaching to the office concerned at the time the employee commences leave.
- 1.5.2 The loading is to be applied as follows:
 - 1.5.2.1 If employed other than a shift worker or as a seven-day week worker,

either;

a loading of 17¹/₂ percent of the salary up to a maximum of \$1,091.10 for any one full entitlement of annual leave,

or

the allowances and penalties payable had the employee not been on leave during the relevant period, whichever is the greater.

1.5.2.2 If employed as a shift worker or a seven-day week worker (i.e. an employee who is working rotating shifts on seven days a week, or who is rostered to work regularly on active duties on Saturdays, Sundays and public holidays),

either;

a loading of 20 percent of salary up to a maximum of \$ 1,091.10for any one full entitlement of annual leave,

or

the allowances and penalties payable had the employee not been on leave during the relevant period,

whichever is the greater.

1.5.2.3 An employee who is employed for part of a year as a shift worker or a seven day week worker is to be paid a loading as prescribed in 1.5.2.2 on a pro rata basis for completed months worked as a shift worker or a seven-day week worker and for the balance to be paid a loading as prescribed in 1.5.2.1.
