South Australian Employment Tribunal Rules 2024

116. Enterprise Agreements

(1) Parties seeking approval of an enterprise agreement are to file an electronic copy of the agreement in Microsoft word format, an electronic copy executed by or on behalf of all parties to the agreement, and an application in the approved form A32.

(2) Where the Tribunal considers that the enterprise agreement is capable of being approved without a hearing, a notice will be issued to the parties and any representatives to that effect and will be published on the Tribunal website.

(3) Where notice is issued under sub-rule (2) and an eligible person wishes to be heard, they must advise the Tribunal and the parties in writing within the period specified in the notice under sub-rule (2).

(4) Except in the case of a provisional enterprise agreement, an affected employer must on receipt of a copy of any notice issued by the Tribunal under sub-rule (2), display the notice in accordance with this rule on a noticeboard or equivalent at the relevant workplace/s and circulate the notice by email to all affected employees.

TO: THE PARTIES TO THE ABOVE PROPOSED ENTERPRISE AGREEMENT

The parties have applied to SAET to approve an Enterprise Agreement filed on 17 Jun 2026 which is made between the employer and employees of the employer.

The Agreement relates to wages, salaries and/or conditions of employment for all employees who are classified pursuant to Appendix A of the enterprise agreement of the employer and whose employment is governed by the South Australian Salaried Municipal Officers Award.

On the basis of documentary material presently submitted in support of the application, SAET is satisfied that the Agreement should be approved.

SAET therefore gives notice that any party seeking to be heard in relation to the application must advise SAET in writing setting out the objection or any other consideration with SAET by **7th September 2026**. A copy of the advice is also to be supplied to the other parties to the Agreement. As soon as practicable after that date SAET will either approve the Agreement or otherwise deal with the matter as it sees fit.
